

5. DURATION OF THE COURSE:

The duration of the course is four years for B.Sc. Nursing.

The maximum period to complete the B.Sc. Nursing course successfully shall not exceed twice the actual duration of the Course (Eight years)

6. ELIGIBILITY FOR ADMISSION

Academic Eligibility:

Candidates who have passed the Higher Secondary Examination of the Board of Higher Secondary Education, Kerala or examination recognized equivalent there to, with 50% marks in Physics, Chemistry, Biology and English put together, are eligible for admission.

Relaxation of marks: - Candidates belonging to Socially and Educationally Backward Classes (as per G.O (P) No. 208/66/Edn dated 02/05/1966, G.O (MS) No. 95/08/SCSTDD dated 06/10/2008 and amendments thereof, with total annual family income not exceeding Rs.4.5 lakhs, will have a relaxation of 5% marks in the qualifying examination. They need only 45% marks in the case of Biology and 45 % marks in the case of Physics, Chemistry and Biology put together. The Scheduled Castes and Scheduled Tribes candidates need only a pass in the qualifying examination. The relaxation of marks in the qualifying examination extended to SEBC candidates only will be applicable to OEC candidates.

Eligibility Certificate: - Candidates who have passed their qualified examination from outside the State of Kerala shall produce the certificate of recognition and equivalency of qualifying examination from the University/ Board of Higher Secondary Examination concerned of Kerala. This should be furnished at the time of admission

Age: Applicants should have completed 17 years of age as on the 31 December 2024. Self-attested copy of relevant page of school record namely SSLC/ICSE/CBSE certificate showing Date of Birth/Copy of the birth certificate from appropriate authority should be furnished along with the application as proof of age

7. HOW TO APPLY

Merit seats (50%) are filled up by LBS Centre. There will be separate application for Management seats (50%)

Submission of more than one application by a candidate will lead to rejection of the applications for the same course submitted subsequent to the first application

8. SELECTION

Applications by the students shall be submitted through online- www.nursing.snims.org

Selection is based upon merits of 12thor equivalent examination. Rank list is prepared by analyzing the aggregate of marks scored in Physics, Chemistry, Biology and English. Candidates should bring all the documents in original for verification at the time of admission. Any false information will lead to cancellation of admission.

9. ADMISSION

Admission will be subjected to the general information and rules stipulated as per the Prospectus for Admission to Professional Degree Courses 2024 in Nursing for Government merit seats and further amendments / orders issued by Government / Governing Body of SNCON regarding the admission. Selected candidates will be informed the date and time of

interview and admission, in due course, through Personal Email. The fee will be as fixed by the Government/ Governing Body. All the selected students should get themselves vaccinated against Hepatitis B and Covid 19 before admission.

10. OTHER INSTRUCTIONS

Preventive measures against ragging: -

According to the Kerala Prohibition of ragging Act, 1998, 'ragging' means doing of any act by disorderly conduct to a student of an educational institution, which causes or is likely to cause physical or psychological harm or raising apprehension or shame or embarrassment to that student and includes teasing or abusing or playing practical jokes or causing hurt to such students or asking a student to do any act or to perform something which such student will not in the ordinary course be willing to do. All institutions will have to abide by the directives of the Honorable Supreme Court of India, Dated May 16, 2007 in SLP No. (S) 24295 of 2006 University of Kerala Vs Council, Principal's Colleges, Kerala &Ors [with SLP (C) No. 24296-99/2004 & W.P (Crl) No. 173/2006 & SLP (C) No. 14356/2005] and the recommendations approved by the Honourable Supreme Court of India on effective prevention of ragging in educational institutions. In case, the applicant for admission is found to had indulged in ragging in the past or if it is noticed later that he / she has indulged in ragging, admission may be refused or he/she shall be expelled from the educational institution. It shall be the collective responsibility of the authority of the institution to see to it that effective steps for preventing ragging are taken. Anti- ragging committees and anti-ragging squads will have to be formed to

take effective measures against ragging and they should adhere to the stipulations and effectively monitor and comply with the directives. Each student of the institution and his/her parents, or guardian are required to submit a combined undertaking at the time of registration/admission in prescribed format available in Annexures which is mandatory for registration/ admission. (Annexure – I & II)

Substance Abuse Policy

Sree Narayana College of Nursing has the responsibility to maintain an educational environment contusive to academic and clinical achievements. The Sree Narayana College of Nursing recognizes that the Substance Abuse may interfere with student's educational objectives as well as academic environment within the campus. Therefore Sree Narayana College of Nursing has a stringent policy governing the use of tobacco, alcohol and other abusive substances. The purchase, possession, use, conception, sale, distribution, or storage of any alcoholic beverages, controlled substance or illegal drugs is prohibited on the campus, training sites, student events, conferences and other activities. The said policy is applicable to the existing students as well as to the newly admitted students. As per the "Prohibition of Sale of Cigarettes and Other Tobacco Products around Educational Institution Rules, 2004", "Tobacco Products Amendment Rules, 2005" and "Prohibition of Smoking in Public Places Rules, 2008" smoking is compete banned in and around the Educational institutions, Auditorium, Library, Canteen and Hospitals. The students as per this policy are requested to adhere strictly the norms as stated below.

- 1. The purchase, possession, use, conception, sale, distribution, or storage of any alcoholic beverages, controlled substance or illegal drugs is prohibited on the campus, training sites, student events, conferences and other activities.
- 2.Under suspicious circumstances the students may be tested at random for substance abuse at any point of time during their stay on campus.

3. If any student of Sree Narayana College of Nursing is violating this policy it could potentially lead to termination of student. 4. An affidavit to this effect shall submitted by students and their parents at the time of admission (Annexure – III & IV).

Security:

The institution is under CCTV surveillance. All areas of the Institution are covered, except toilets and designated private zones. CCTV policy is implemented. There is one entrance and exist to the campus. Any student going out of campus should get permission from the College authorities and the gate pass should be shown to security at the main gate.

Uniform

There will be a designated uniform for students and it's compulsory. Students will be permitted to attend classes or clinical postings only in designated uniform. They should come to the College properly and neatly dressed in accordance with the college dress code and have to wear prescribed uniform with ID card while they are in college campus and additionally overcoat is compulsory in the clinics.

Parent Teacher Association

There is an active PTA in this institution and all Non-academic action will be implemented with the approval of PTA. All the PTA member and Executive Committee members should attend the PTA General Body and Executive Committee meetings respectively without failure.

Attendance:

Duration of the B.Sc. Nursing course is four years. Internship integrated practice is incorporated with respective practical hours in each year.

The candidate shall complete the stipulated course period as specified in the B.Sc. nursing course regulations to be eligible for the award of Degree.

Each candidate should put in a minimum of 80% of attendance of the prescribed hours in each subject in Theory & in Practical separately wherever applicable in each academic year to

appear for the University examination. However, a candidate shall complete 100% attendance in practical before the award of Degree.

There is no provision for condonation of shortage of attendance for B.Sc. Nursing programme. 80% attendance for both theory and practical separately are required for appearing University examination as per Statutory Council Regulations.

11. UNIVERSITY AND SYLLABUS

Sree Narayana College of Nursing is following the syllabus stipulated by the KUHS and Indian Nursing council.

12. RECOGNITION/AFFILIATION

Sree Narayana College of Nursing is recognized by Indian Nursing Council, approved by Kerala Nurses and Midwives Council and affiliated to Kerala University of Health Science (KUHS)

13. SYSTEM OF EXAMINATION

Examinations are conducted as prescribed by the Kerala University of Health Sciences

14. FEE STRUCTURE

B.Sc. Nursing Course 2024

Govt. Merit / Management seats
Rs. 73025/- per year
Rs. 23300/- First year,
Rs. 19300/- Second, Third & Fourth year

Caution Deposit (One Time) is Rs - 10000/- (Refundable at the end of the course subject)

Yearly fee should be remitted within 30 days of the starting month of every academic year; otherwise fine will be collected as per the stipulated policy of the College.

Note:-

1. Fees are subjected to change by Government/University Orders from time to time.

- 2. Regarding the discontinuance from the course and cancellation of the admission, it shall be subject to the legal and factual scrutiny and decision of the ASC/FRC.
- 3. If any student cancel his/her admission after the date of closing of admission fixed by Govt., he/she is liable to pay liquidation damages as per the Govt.order/Court order/decision of Admission Supervisory Committee.

15. HOSTEL FEES

Hostel fee (Rent Rs.24000/- Mess fee Rs.48000/-) per year.

16. OTHER FACILITIES

College infrastructure: Sree Narayana College of Nursing is situated in the SNIMS campus, has adequate facilities as per INC /KNMC/KUHS norms

College office: The College has well designed Principal office, Vice Principal office, HOD rooms, faculty rooms and office section. The office works from 9am to 5pm on all days except holidays

Laboratories: There are six laboratories set up as per the guidelines of INC. All the laboratories have adequate quantity of manikins, simulators, models, instruments specimens which facilitate learning before the real exposure in clinics.

Store: The store caters to the immediate stationary needs of the students at very nominal charge and is open on all working days

Canteen and refreshment: The canteen caters to all the additional needs of the students and staff by providing them with tasty and nutritious food at very reasonable prices. Cafeteria is available at different locations within the campus which provides easy access for students seeking to refresh themselves with snacks during short breaks.

Banking: Federal bank ATM counter is available in the campus, which is accessible to all staff and students

Transportation: The College has well established transport facilities with its own fleets of buses to transport students and staff.

Counseling: Counseling services are available for the students to improve their study habits, adjust in clinical area, reduce stress and promote optimal personal and professional development.

Library: The library is well stocked with sufficient latest volume of books, journals, magazines, news papers and dissertations of all disciplines of Nursing. The library works from 9am to 6pm on all week days except on holidays.
